 Kopi-Oh is Black Coffee in local coffee or drink shops."

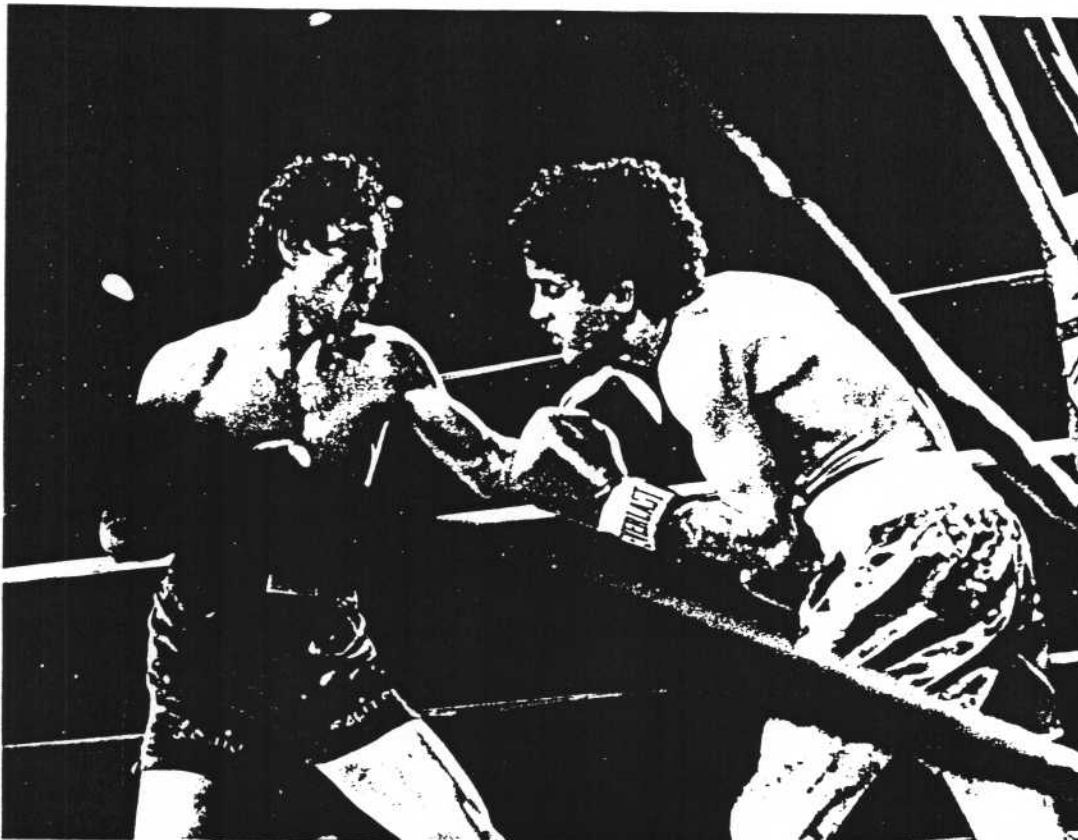
DONNY POOLE and LOUIE ESPINOZA

David Wolf, manager of welterweight Donny Poole and featherweight Louie Espinoza, as well as Ray Mancini, has forwarded 22 pages of clippings on Poole and Espinoza along with their complete records. In addition to the usual won-lost information the number of knockdowns scored in each fight is included. In Poole's first 27 fights (17 knockouts) through May 10, 1985, he has scored 38 knockdowns - an incredible average of 1.4 per bout. Espinoza, through Feb. 16, 1985 has recorded 13 knockdowns in his 15 bouts.

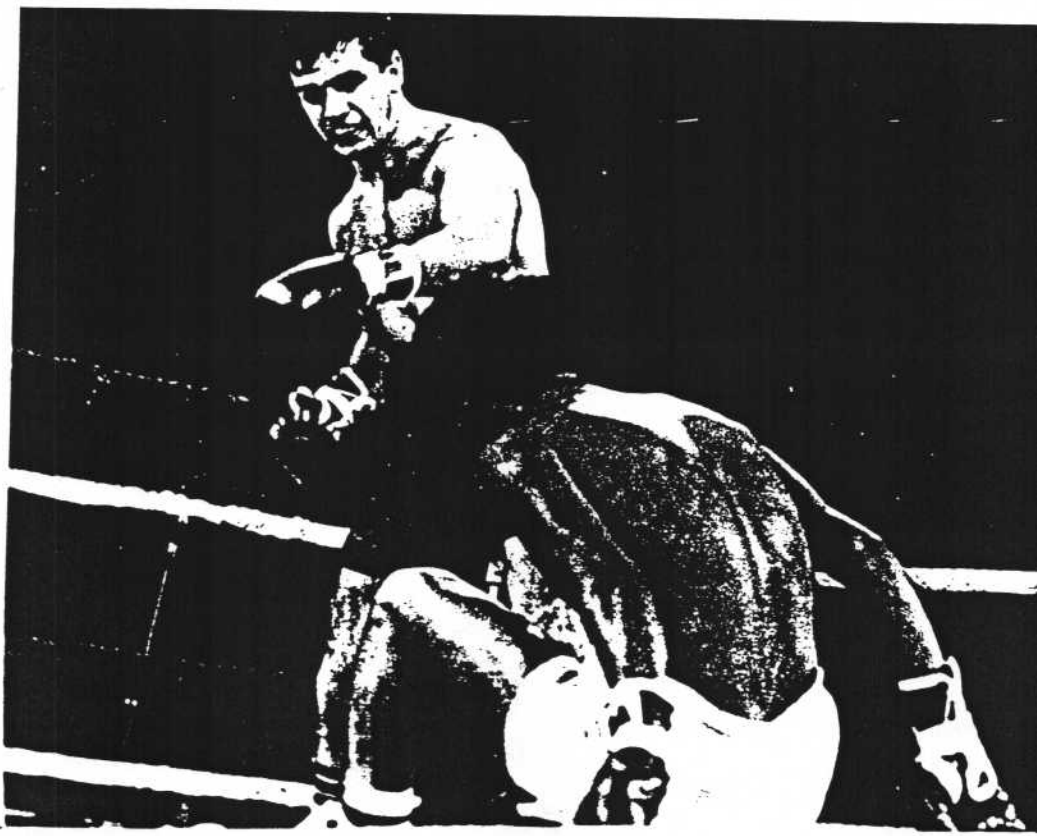

Bob Diamond writes, "I recall reading that Eder Jofre was ahead on all three cards for a bout vs. Manny Elias but that a fighter had to be ahead by at least three points in a non-title fight to gain a decision, otherwise the fight was a draw. Do you know if this is true? I wonder since Jofre had three draws in his early record, were they fights he was winning? Also, Carlos Monzon had 8 or 9 draws. Was this rule in effect in Argentina as well as Brazil? Perhaps someone familiar with South American boxing could find out who was actually the winners in these early Jofre and Monzon fights."

"The Boxing Rambler" - Johnny Shevalla

"The greatest talent of all is sheer confidence". - Jim Bishop (King Features syndicated columnist, story teller. Calls himself - a "reporter.")

John Schulian, columnist for the Philadelphia Daily News, received the 13th annual Nat Fleischer award for excellence in boxing journalism from the Boxing Writers Association of America. The award honors the late founder - editor - publisher, Nat Fleischer, of boxing's bible - Ring magazine. Fleischer - the guiding light of Ring 1922-1972.

Ken Norton, Jr. - The hero of UCLA's 17-14 victory over California (Oct., 1984) was linebacker Ken Norton, Jr., son of former heavyweight champion Ken Norton.

Freddie Steele - Hank Kaplan, boxing's rememberer, recalls seeing Steele lose to Fred Apostoli in Madison Square Garden. (The old Garden on 8th Avenue). Hank felt very sorry for Steele that night. The old Garden was the Mecca for boxing. This tourist still carries the picture - standing in the front of the marquee - a shrine. It was magic! Nat Fleischer had his Ring headquarters in the Garden building.

Hank Kaplan writes, "Beau Jack is in the gym everyday and looks very well. He is training heavyweights Jeff Sims." Beau Jack is one of my very favorite boxing champions.

Stillman's Gym - Located near the old Madison Square Garden on Eighth Avenue. Some 35,000 boxers trained in Lou Stillman's Gym during its 35 years of service to boxing.

TUG WILSON

IBRO Newsletter #13 contained a record of bareknuckle fighter, Tug Wilson. Date of death was not included. The following piece from The Mirror of Life and Boxing World, June 22nd, 1912 may shed some light and help researchers find the exact date of his death.

"The death of Tug Wilson in a Hamilton (Ohio) hospital last month recalls the most notable feat of the man who once claimed to be champion of England. Wilson, who was also known as James, or Long, Collins, was taken to America by Richard K. Fox to face John L. Sullivan, the Boston Terror. A bareknuckle fight between them could not be arranged, and at length Sully offered Wilson 1,000 dollars and half the gate receipts if he succeeded in lasting four rounds with him with the gloves.

"The affair, it can hardly be called a contest, created great interest at the time, and was brought off in Madison Square Gardens, New York, in July, 1882. The conditions of the match greatly favoured Wilson, and he took full advantage of them, going to boards for long counts on no fewer than nine occasions in the first round, so we are told. That was pretty galling to John L., who wanted to knock him out as quickly as he could, but stopping Sullivan's mighty right-handers was no part of Wilson's game, and what time he was not on the boards, he displayed, it is said, considerable merit as a sprinter. Anyway, he did what he set out to do, namely, last the four three-minute^{rounds} through. Some years ago Wilson and the late Jem Mace were two of the attractions with a boxing booth that toured the country, and it was printed in large type on the bills that Wilson was the only Englishman to defeat the great John L. Sullivan! Just how much of a defeat it was the reader can very easily guess."

SOUTH AFRICAN OLYMPIANS

Quite a few IBRO members are interested in learning of fighters' fortunes after they have left the ring. Chris Greyvenstein does an excellent job of this in his history of South African boxing, The Fighters (reviewed in newsletter #16, p. 9).

In a recent letter he writes, "By the way, you might be interested in the whereabouts of our Olympic Gold medallists. Clarence Walker, Willie Smith and Dave Carstens are dead. Laurie Stevens is retired as the owner of a sports outfitters in Johannesburg and lives in Durban. His health is frail but he looks good enough for a few more years. Gerald Dreyer is a senior sales representative in his native Pretoria. I see him quite often as we have been friends since boyhood. George Hunter is still alive (he's only in his mid-fifties) but nobody ever hears from him. He fought for a couple of years as a pro but without startling success, unlike Gerald who won the Empire welter title (in those days we were still part of the British Empire), enjoyed a Ring magazine world rating and fought Chuck Davey once.

"Other Olympians who are still very much around are Vic and Willie Toweel, Johnny Arthur and Daan Bekker. Vic, who held the professional bantam title 1950-52 is a much revered South African sportsman. Brother Willie who was a world-rated pro for many years and fought the likes of Jimmy Carter, Orlando Zulueta, Dave Charnley, Len Matthews, Emile Griffith and who boxed a draw in a world bantamweight title fight with Robert Cohen, is manager-trainer of Piet Crous, who recently won the world cruiserweight title from Ossie Ocasio. Vic attends fights but has never bothered to train or manage anyone. Johnny Arthur is a wealthy businessman in the Eastern Transvaal, Daan Bekker is a police officer who does a fair amount of training of boxers. Willie Ludick is a lay preacher and has nothing to do with boxing. His son, Edwin, is one of the best high jumpers in Africa."

JOHNSON-JEFFRIES SIGNING

Ocania Chalk has supplied a photo of the preliminary signing for the Jack Johnson-Jim Jeffries bout. The photo was taken on October 29, 1909 at the Hotel Albany in New York, NY. Mr. Chalk would like help in identifying the people in the picture. He has been able to identify eight of the men.

Seated from left to right are: Jack Johnson, George Little, Jim Jeffries, Sam Berger. Al Woods is seated almost directly behind the mustachioed Little and is partially obscured. Only three of the men standing are identified: Bob Edgren (extreme left above Johnson's right shoulder); Bob Anderson (directly behind Johnson); and TAD - Thomas Aloysius Dorgan (directly behind Jeffries).

BAREKNUCKLE NOTES - Peter Hatton

Continuing with his research into the middleweights in the mid 19th century, Peter Hatton writes in a letter dated 16 April:

"What I've been looking at in this vacation is Nat Langham who was clearly responsible like Randall for creating the concept of the middleweight division WITH THAT NAME (unlike Randall's 'Champion of the Lighter Weights'.) What happens when he retires seems quite clear. He becomes manager of Bob Travers (a Negro 'Massa Ebony') and plans to establish Bob as his accepted successor. The main reasons why no one makes this claim are that both Sayers and Mace are within 7 pounds of 154 but with renewed interest in and not that much talent in the Open category (1855 is the public subscription for the Open Belt) a separate claim would seem inappropriate and Open contesting was more lucrative and not at an impossible weight disadvantage.

"The two leading under 154s were Bob Brettle of Birmingham and Travers. Travers had beaten all the leading other self-designated middleweights: Mike Madden (to whom Mace forfeited in 1854), George Crockett, Bill Hates and Jesse Holton. Brettton's claim would have been the stronger as he beat Travers in 1858 and then Mace on 21 September 1858. He now looked like a possibility for an Open contender. Sayers by this stage was in correspondence for a U.S. challenge from Heenan or Jones and was probably going to retire thereafter. Brettton was unsure whether he was aiming for middle now or Open after Sayers.

"They agreed to meet NOT FOR ANY TITLE in order not to prejudice Sayers' American negotiations. They met at Ashford, Kent on 20 September 1859 and Sayers won easily in 6 rounds and 15 minutes (Ring Record Book please add to Sayers record). The beating was bad enough to cause Brettle to not be so good afterwards and a further loss to Mace (21 September 1860) and he was out of the top flight. Travers had challenged Mace (21-22 February 1860) and his disqualification under rule 13 ('wilfully throwing himself down without receiving a blow') destroyed his style (and would have equally been applicable to Langham in his victory over Sayers). The rule was added (to Broughton's 1743 Rules) in the New Rules of 1838 (and had been added to the articles of many fights from 1805). It was necessary because losers were stringing out fights and some ridiculous 'no contests' were occurring when both fighters were cautious. However, it seems harsh to use it against fighters like Langham and Travers who aimed to win by long range blows to the head. Its stricter application in 1860 seems to have led to a greater emphasis on close-range wrestling and falling on one's opponent in a throw as a means of exhausting him and may well have contributed to the Marquis of Queensbury feeling the need to draw up his rules in 1867.

"That is all for this vacation. I'll surface again in July."

CHARIOTS OF FIRE - Part 2

George Ross, 59/34 Norman Terrace, Everard Park, South Australia 5035 forwards a clipping from an Adelaide newspaper about the recent Oceania Games.

It reads in part, "Victorian fighter Joe Huljak placed religious beliefs before an Oceania championship gold medal. He was disqualified from the light welterweight final yesterday because he weighed in over the limit, but the real reason goes back to Saturday night. It was then that the 19-year-old Huljak won a unanimous points decision over Ming Ching Shiao of Chinese Taipei in a semi-final. After the fight the Catholic boxer told his trainer, Derek Herbert, of Collingwood, that he would forfeit the final against Renato Cornett, of NSW, because of his religious beliefs. Toowoomba priest Father Tom Sheeran, a referee at the titles, was asked to speak with Huljak about the predicament. But after the talk, Huljak remained adamant that he would not fight. Yesterday, Huljak ate a hearty breakfast and then headed off with Herbert for the 8 a.m. weigh-in for the championship final. A check weigh by Herbert just before

1985 BOXING RECORD BOOKS - Ring Record Book and Pugilato

The two most comprehensive annual boxing record books are now available. They compliment each other quite well with the strengths of one remedying the weaknesses of the other and vice versa - thus both are required for all serious boxing enthusiasts.

The 1985 Ring Record Book and Boxing Encyclopedia has become the standard in its field in its 44th year of publication. Among the new features which editor Herbert G. Goldman has included are a complete list of all world bantamweight championship bouts and a completely new listing of the records of all the lightweight champions featuring many additions and corrections supplied by IBRO members. Since fewer copies have been printed of the 1985 edition than in recent years, members are urged to order as soon as possible for in all likelihood the edition will be sold out shortly. The list price is \$29.95 and it can be purchased from The Ring Book Shop, 130 W. 37th Street, New York, NY 10018. Recent issues of The Ring have included a discount coupon for purchase of the Ring Record Book.

The 1985 edition of "The 'Bible' of Boxing (La 'Bibbia' del Pugilato) edited and published by Dott. Giuseppe Ballarati has also recently been released. This 750 page reference work contains among its features: a multi-lingual (Italian, English, French, German and Spanish) glossary of boxing terms; a complete history of world, European and Italian championship bouts; brief biographies and photos of the most important people of the boxing world (including quite a few IBRO members); and biographical information and amateur boxing accomplishments of virtually all the leading fighters of the world today with more than 2,500 records. Dott. Ballarati has once again compiled an invaluable reference book that should be on the shelves of all boxing fans. IN THE HOUSE OF REPRESENTATIVES

April 18, 1963

Richardson Preyer, Mr. Leland, Mr. Eckart of Ohio, Mr. Dingell, and Mr. Williams introduced the following bill, which was referred to the Committee on Energy and Commerce.

A BILL

To establish a United States Boxing Commission, and for other purposes.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That there is established a nonprofit corporation to be known as the United States Boxing Commission (hereinafter in this Act referred to as the "USBC"). The USBC shall maintain its principal office and headquarters in Washington, D. C.

ORGANIZATION

SEC. 2. The Board of Directors of the USBC shall, as soon as practicable after being appointed and qualified, adopt

constitution and bylaws and take whatever other steps are necessary to complete the organization of the USBC.

PURPOSES

SEC. 3. The purposes of the USBC shall be to—

- (1) propose changes in the rules of the sport of professional boxing to ensure the safety of participants and establish a uniform set of rules for the various State Athletic or Boxing Commissions to follow;
(2) conduct research into the causes of boxing and boxing-related injuries and recommend preventive steps;
(3) establish minimum standards and procedures for various physical and mental examinations;
(4) establish minimum standards for the availability of medical services at professional boxing matches;
(5) provide for a voluntary pension and life and health insurance fund for professional boxers and other members of the professional boxing community;
(6) provide a unified national computer source for the collection, storage, and retrieval of (A) a list of professional boxers, and (B) the medical records, won-loss records, size, weight, and business associates of such boxers;
(7) research and establish minimum standards for the manufacturing and use of boxing equipment, includ-

ing gloves, head gear, ring ropes, and other boxing-related equipment;

(8) provide a mechanism for the national certification of trainers, cut men, referees, judges, ringside physicians, and other professional boxing assistants as determined by the USBC, in order to guarantee minimum proficiency levels for such persons;

(9) issue an annually renewable USBC certification card to each boxer, trainer, cut man, referee, judge, ringside physician, and to other professional boxing assistants as determined by the USBC, stating that they have met all USBC minimum standards and listing, in the case of boxers, an accurate record of their medical history, biographical information, and won-loss record;

(10) conduct discussions and enter into agreements with foreign boxing entities in methods for applying minimum health and safety standards to foreign boxing events and foreign boxers, trainers, cut men, referees, judges, ringside physicians, and other professional boxing assistants; and

(11) review existing State Athletic or Boxing Commission rules and regulations for professional boxing and provide assistance to such Commissions in meeting USBO minimum health and safety standards.

POWERS OF CORPORATION

SEC. 4. (a) The USBC shall have perpetual succession and the power to—

- (1) serve as the coordinating body for all efforts in the United States to establish and maintain uniform minimum health and safety standards for professional boxing;
(2) charge dues for membership and reasonable fees for services it performs;
(3) sue and be sued;
(4) make contracts consistent with the purposes of the USBC;
(5) acquire, hold, and dispose of such real and personal property as may be necessary for its corporate purposes;
(6) accept gifts, donations, legacies, and devises in furtherance of its corporate purposes;
(7) borrow money to carry out its corporate purposes, issue notes, bonds, or other evidences of indebtedness therefor, and secure the same by mortgage, subject in each case to the laws of the United States or of any State;
(8) establish, regulate, and discontinue subordinate organizations;

(9) establish criteria for membership in the USBC;

determine benefits and responsibilities which pertain to membership, and receive and expel as members such existing organizations and individuals as may be deemed desirable and proper to carry out the corporate purposes;

(10) publish a newspaper, magazine, or other publication consistent with the corporate purposes; and

(11) do any and all things necessary and proper for a non-profit corporation to accomplish the purposes set forth in section 3, consistent with the provisions of this Act, the constitution and bylaws of the USBC, and other applicable law.

(b) The USBC shall not issue capital stock or engage in business for pecuniary profit or gain.

(c) The USBC shall not affect contracts for the television distribution of boxing events.

(d) The USBC shall not engage in the sanctioning of boxing events or the ranking of professional boxers.

(e) The USBC shall have the exclusive right to use the names "United States Boxing Commission" and "USBC", and any person who, without the permission of the USBC, uses such name or any other exclusive name, trademark, emblem, symbol, or insignia of the USBC for the purpose of inducing the sale of any goods or services, or to promote any

exhibition, performance, or sporting event, shall be subject to suit in a civil action by the USBC for the remedies provided in the Act of July 5, 1946 (60 Stat. 427; 15 U.S.C. 1051 et seq.), popularly known as the Trademark Act of 1946.

BOARD OF DIRECTORS

SEC. 5. (a) The USBC shall have a Board of Directors which shall consist of citizens of the United States, including—

- (1) 2 acting State Athletic or Boxing Commissioners to be appointed by the President, with the advice and consent of the Senate, from persons recommended by the Speaker of the House of Representatives;
(2) 2 acting State Athletic or Boxing Commissioners to be appointed by the President, with the advice and consent of the Senate, from persons recommended by the majority leader of the Senate;
(3) one former boxer, boxing trainer, judge, or promoter, to be appointed by the President, with the advice and consent of the Senate, from persons recommended by the Speaker of the House of Representatives;
(4) one former boxer, boxing trainer, judge, or promoter, to be appointed by the President, with the advice and consent of the Senate, from persons recommended by the majority leader of the Senate;

(5) two sports medicine physicians, one to be appointed by the President, with the advice and consent of the Senate, from persons recommended by the Speaker of the House of Representatives and one to be appointed by the President, with the advice and consent of the Senate, from persons recommended by the majority leader of the Senate;

(6) two citizens of the United States with an interest in and knowledge of the sport of boxing, but with no current financial interest in that sport, one to be appointed by the President, with the advice and consent of the Senate, from persons recommended by the Speaker of the House of Representatives and one to be appointed by the President, with the advice and consent of the Senate, from persons recommended by the majority leader of the Senate; and

(7) six nonvoting members of whom—

- (A) 2 shall be Members of the House of Representatives appointed by the Speaker of the House of Representatives;
(B) 2 shall be Members of the Senate appointed by the majority leader of the Senate, and
(C) 2 shall be members of the boxing media, appointed by the Board of Directors.

(b) Initial appointments under subsection (a), except those appointed under paragraph (7)(C) of such subsection, shall be made within 60 days after the date of enactment of this Act.

(c)(1) Voting members of the Board of Directors shall be appointed to 5 year terms, except that—

- (A) the initial appointments made under subsection (a) (3) and (4) shall be for a 1 year term,
(B) the initial appointments made under subsection (a)(5) shall be for a 2 year term,
(C) one of the initial appointments made under subsection (a)(1) and one of the initial appointments made under subsection (a)(2) shall be for a 3 year term, and
(D) the initial appointments made under subsection (a)(6) shall be for a 4 year term.

(2) Non-voting members of the Board of Directors shall be appointed to 2 year terms.

(d) If any member of the Board of Directors is unable to serve his full term of office or becomes unqualified to serve in such position, a new member shall be appointed to serve the remainder of such term of office in the same manner in which the original appointment was made.

(e) At the initial meeting of the Board of Directors the Board shall elect one of the members appointed under sub-

1 section (a) (1) or (2) to be the chairman, to be known as the
2 "Commissioner", who shall have administrative responsibility
3 for the USBC.

4 (f)(1) The Commissioner shall be paid at a rate not to
5 exceed the daily equivalent of an annual rate of pay of
6 \$45,000 for each day, including travel time, during which the
7 Commissioner is engaged in the actual performance of the
8 official business of the USBC, and shall be reimbursed for all
9 travel and other expenses incurred in the performance of such

OLYMPIC MEMORIES - Tan Wee Eng

In reviewing The Olympic Games Boxing Record Book, Tan Wee Eng, "floated down memory lane" and shared his memories of "some professional near-champions who have contributed colorfully to world boxing:"

Rocky Gattellari - Australia - Flyweight 1960 Rome

World flyweight contender. Rated by The Ring in 1964, 65, 66. Lost to Salvatore Burruni in world flyweight title bout in Sydney on December 2, 1965.

Frank Battaglia - Canada - Lightweight 1928 Amsterdam

Rated by The Ring 1931-33. No. 1 contender when Marcel Thil was the champion. Fought Gorilla Jones, Freddie Steele, Ben Jeby, etc. Lost to Freddie Steele for NBA-New York world title in 1937.

Ian Clyde - Canada - Flyweight 1976 Montreal

Angelo Dundee's hopeful champion protege. So far, Ian Clyde was unsuccessful in all his titular bouts in 1983/84 for the USBA, NABF and IBF flyweight championships.

Gunnar Barlund - Finland - Heavyweight 1932 Los Angeles

Rated No. 3 world contender when Jimmy Braddock was champion in 1936, by The Ring.

Henry Cooper - Great Britain - Light heavyweight 1952 Helsinki

Rated by The Ring 1959 to 1962. Highlights were his two fights with Floyd Patterson and Cassius Clay in London in 1966.

Dai Dower - Great Britain - Flyweight 1952 Helsinki

World contender rated by The Ring - 1953 when Yoshio Shirai was king and from 1954-56 when the champ was Pascual Perez. Was koed by Pascual Perez in Buenos Aires in titular bout in 1957.

Laszlo Papp - Hungary - 1948, 1952, 1956 - Light ' middleweight and middleweight

Rated world contender by The Ring from 1962 to 1964.

Luigi Minchillo - Italy - 1976 Montreal - Welterweight

Minchillo gave The Hitman, Thomas Hearns a good fight recently in Joe Louis Stadium in Detroit. Rated by WBA world Jr. Middleweight contender 1984. (I was lucky to see part of this bout at home on TV - tuned to Indonesian station !)

Kenji Yonekura - Japan - Flyweight 1956 Melbourne

Rated world contender in bantamweight class by The Ring 1959-60. Beaten by Joe Becerra for world bantamweight title in Japan in 1960.

Rudi Lubbers - Netherlands - 1964 Light heavyweight Tokyo

Highlight of his career was his 12 rounder loss to Cassius Clay in Djakarta in 1973. (My local pal, Lim Kee Chan was a judge in that fight).

Bep Van Klaveren - Netherlands - Featherweight 1928 Amsterdam

World welterweight contender rated by The Ring from 1932 to 1935. Fought 'em all - Billy Petrolle, Benny Levine, Bill Rafferty, Eddie Shapiro, Jack Caroll in Sydney, Australia; wins over Ceferino Garcia, Young Corbett III, Kid Azteca, Stanley Loayza, Kid Tunero, Anton Christoforidis and Anacleto Locatelli.

Haakon Hansen - Norway - Lightweight 1924 Paris

Had 38 fights in Chicago from 1927 to 1932 including bouts against Jock Malone, Tuffy Griffiths, Frank Battaglia, Ray Tramble and Jack Kilbourne.

OLYMPIC MEMORIES (continued)

Otto Von Porat - Norway - 1924 Paris Heavyweight

World contender for light heavyweight in 1927 and heavyweight division in 1928/29 by The Ring. Battled 'em all on Uncle Sam's shores in the Roarin' Twenties - Sully Montgomery, Young Stribling, Big Boy Petersen, Teddy Sandwina, Pierre Charles, Chuck Wiggins, Paulino Uzcudun, Battling Levinsky, Tom Heeney, Johnny Risko, KO Christner, Phil Scott, Jack Renault, Paul Swiderski and Don McCorkindale. Norway's "Mr. Boxing" John Wiksen's letter informed me that 'Otto Von Porat is dead'. May his soul rest in peace.

Al Asuncion - Philippines - Flyweight 1952 Helsinki

World bantamweight contender rated in 1956 to 1958 by The Ring.

Don McCorkindale - South Africa - Light heavyweight 1928 Amsterdam

Rated top world contender in heavyweight class by The Ring in 1933. Lost to Primo Carnera in London in 1932 when The Ambling Alp was on his way to becoming world champion. Also fought 'em all including Young Stribling, Walter Neusel, Paulino Uzcudun, Larry Gains, Patsy Perroni and King Levinsky.

Willie Toweel - South Africa - Flyweight 1952 Helsinki

Rated world bantamweight contender by The Ring in 1954. Fought title bout draw with Robert Cohen in Johannesburg in 1955 over 15 rounds.

'Smiler' Van Rensburg - South Africa - Lightweight 1952 Helsinki

Remembered for his fights with Willie Toweel and Mike Holt.

Olle Tandberg - Sweden - Heavyweight 1936 Berlin

Fought Joey Maxim, Jersey Joe Walcott and beat Joe Baksi in 1947.

Carmen Barth - U.S.A. - Middleweight 1932 Los Angeles

Fought Ken Overlin, Solly Krieger, Teddy Yarosz and lost to Freddie Steele in world title bout for NBA-New York championship in 1938.

Duane Bobick - U.S.A. - Heavyweight 1972 Munich

World heavyweight contender rated by The Ring 1975 to 1977. KOed Mike Weaver in 1974 and was stopped by Ken Norton in 1977 and John Tate in 1979, respectively, in non-titular bouts.

Henry (Pappy) Gault - U.S.A. - Flyweight 1948 London

World bantamweight contender rated by The Ring 1952/53. Lost to Jimmy Carruthers for world bantamweight crown in Sydney over 15 rounds in 1953. Also lost to Robert Cohen in non-titular bout same year.

Steve Halaiko - U.S.A. - Lightweight 1928 Amsterdam

Rated by the Ring world contender lightweight in 1930 and Jr. welterweight in 1931. Fought 'em all - Sammy Dorfman, Sammy Fuller, Sammy Mandell, Wesley Ramey, Babe Herman, Santiago Zorilla, Cocoa Kid, Jimmy Leto, Andy DiVodi, Lou Ambers and others.

Armando Muniz - U.S.A. - Welterweight 1968 Mexico City

World welterweight contender rating by The Ring from 1974 to 76. Beat Hedgemon Lewis, but lost to Angel Espada. Lost to Eddie Perkins for NABF welter title in 1973. Lost twice in world title bouts against Jose Napoles in 1975 and again lost two grueling bouts over 15 rounds for the world welterweight title to Carlos Palomino in 1977 and 1978.

Ellsworth (Spider) Webb - U.S.A. - Light middleweight 1952 Helsinki

Rated world middleweight contender when Sugar Ray Robinson was king. Fought Gene Fullmer, Joey Giardello, was KOed by him in San Francisco in 7th round in 1958.

MORRIE BLOOM

In addition to his many other activities in his status of semi-retirement, David Bloch writes a weekly sports column for the Richmond Jewish News. The following is an excerpt from a recent column.

BUD BLOCH'S JEWS IN SPORTS

A Visit To Chicago



I have recently returned from Chicago where DOROTHY and I had another enjoyable meeting with HARRY HELLER and his wife, GLADYS. Harry, who is the Sports Editor of the Chicago Jewish Sentinel, is also a member of the Illinois Basketball Collegiate Association's (IBCA) Hall of Fame. Naturally, our conversation centered around Jews In Sports and the approaching Maccabiah Games.

On the following day I visited the Spertus College of Judaica where I researched the fistic career of MORRIE BLOOM, an excellent Chicago boxer. Born MORRIS BLUMBERG, he started his career in 1905 as a flyweight and eventually retired after World War I as a welterweight with over 200 bouts to his credit.

Now I have followed this sport since 1934 and was somewhat familiar with Bloom's accomplishments because of the many books and magazines in my own personal collection. However, until I actually researched his record and scrapbooks at the college, I was ignorant of his true worth and ability. Hence, despite being described as "one of the greatest fighters turned out in the Middlewest" by a Chicago newspaper in 1929, I was amazed to learn that he claimed the world's

welterweight title from 1914 to 1917. True, his claim was never universally recognized, and, sadly enough, none of the modern record books list his name as a titular claimant, but the fact remains that I have seen a number of articles in Illinois papers and magazines referring to him as the former champion. The most recent column I have seen appeared in Leo Fisher's Chicago American Column of December 23, 1953 in which this respected sports writer alluded to Bloom's contention.

Was Morris actually a world champion? Purists will probably say no, but I suggest that his claim was as good as other claimants during at least part of that chaotic period in the 147-pound division. Certainly, at the very least, he gained enormous stature by virtue of his assertion.

One bonus that came to light was additional proof that CHARLEY WHITE (ANCHOWITZ) was claiming the lightweight championship as of February 11, 1916. Again, not universally recognized, mind you, but a claim nonetheless.

I would like to thank ELSIE ARLINSKY of the Chicago Jewish Archives for her warm welcome and for

permitting me to view the Morrie Bloom data. I also appreciated her taking the time to copy and send me approximately 25 pages of this rare scrapbook.

DID BARNEY ROSS HOLD THREE TITLES AT THE SAME TIME BEFORE ARMSTRONG PERFORMED THAT FEAT?

The answer to that question hinges on whether the Junior Welterweight title had any official recognition during May 1934 when Ross may have accomplished that feat.

But first- Ross did not give up the lightweight crown in 1933 but did so on April 15, 1935, when he was under suspension by the New York Athletic Commission for refusing to defend his lightweight crown against Lew Ambers. Ross gave weight problems as the reason for abdicating.

New York withdrew recognition of the Junior Lightweight and Junior Welterweight titles on December 31, 1929. The NBA did the same on September 20, 1932. However, Illinois- Ross' home state- dropped out of the NBA on February 23, 1933, and presently I don't know if it recognized Ross as the Junior Welterweight champion. The same is the case with California (an independent body until it joined the NBA on September 7, 1940).

A good many boxing experts never thought much of the junior titles. This was especially true in Europe where, I believe, none of the boxing bodies extended recognition.

Lord Lonsdale, at ringside for the Berg-Callahan contest, disputed the announcer who said that there was such a class as the junior welterweight division (see Gilbert Odd, ENCYCLOPEDIA OF BOXING, page 183).

A forgotten effort to revive that class, which produced a forgotten champion, was made in 1941 when Louisiana and Alabama recognized HARRY WEEKLY as world Junior Welterweight champion (see Weekly in 1943 RING RECORD BOOK).

The August 3, 1935 NEW YORK TIMES reported that the New York Athletic Commission turned down Ross' request to sanction a lightweight title bout between him and the then titleholding Tony Canzoneri. The Commission said that Ross would have to first qualify in that class!

This fact, plus the low poundage Ross showed in many of his pre-1936 title bouts lead me to believe that he, like Armstrong, might better be listed among the all-time lightweight champions instead of among the welterweight champions.

John Robertson points out that the 1984 edition of the RRB lists the second Johansson Patterson bout as a KO 4 in Patterson's record. It is correctly listed as a fifth round knockout in both Johansson's record and in the summary of world heavyweight championship bouts.

He also reports that the 12/16/54 bout between Carmen Basilio and Ronnie Harper ended in the third round and not the fourth as recorded in Basilio's record. His source for this correction was the local Cambridge, Ontario daily.

Some records, from Laurence Fielding

During the late 1920's and early 1930's there were several Jimmy Smiths in boxing, but the best was Jimmy Smith of Philadelphia, the middleweight contender, who beat Ken Overlin and Lou Brouillard. Undated fights: It has been claimed that Smith lost one fight to Pat Haley and that he won over a man named Guidici or Giudici.

ADDITIONS AND CORRECTIONS:

In the record of Tony Canzoneri (1984 RRB, page 735, and others), the fight with Ruby Bradley on Apr. 20, 1931 should be erased. Bradley was kayoed on that date, but it was by Tony Canzoni, not Canzoneri. Canzoni was then a promising bantamweight from Utica, N.Y. Bradley was a good flyweight, but would not have been matched with a great lightweight. (From the Springfield Republican).

In the 1921 record of Joe Lynch (1984 RRB, page 859), the date of his draw with Midget Smith was Nov. 25, and it was at N.Y.C. Also add this fight to his 1922 record: Mar. 27-Johnny Gray, Brooklyn W 12 (New York Times).

In the 1931 record of Art Huttick (1943 RRB, page 233, and IBRO # 14), the date of his win over Jake Denning at Fort Wash. was June 22. (Washington Star).

In the 1935 record of Phil Furr (IBRO # 7), the date of his KO over Johnny Mays was May 13 (thanks to Buddy Ey and the Richmond Times-Dispatch).

In the 1931 record of Lew Massey, in the 1932 Everlast, pages 271-272, the result of his Feb. 23 fight with Harry Blitman is wrong. Massey lost, according to the Philadelphia Inquirer. The 1943 RRB has it right, for both fighters.

Johnny Van Heest. Born: Oct 20, 1870, Escanaba, MI

WATANABE). WILSON DID NOT MEET TONY MARINO IN 1931. ENTRIES SOMETIMES LISTED IN WILSON'S EARLY RECORD, FOR FIGHTS WITH MICKEY SOLOMEN, PAT FLAHERTY, ETC. BELONG TO JACK WILSON, A MIDDLEWEIGHT.
